



BYLAW NO. 12 – 2025 TOWN OF VEGREVILLE

THIS BYLAW NO. 12-2025 OF THE TOWN OF VEGREVILLE, IN THE PROVINCE OF ALBERTA TO ESTABLISH FEES, RATES AND CHARGES FOR SERVICES PROVIDED BY THE MUNICIPALITY

WHEREAS the Municipal Government Act, RSA 2000, c M-26, as amended from time to time (the 'Act'), authorizes the Council of a municipality to pass bylaws for municipal purposes respecting the following matters:

- (a) services provided by or on behalf of the municipality
- (b) the establishment of fees for licenses, permits and approvals

AND WHEREAS the Act provides for the provision of municipality utility services subject to the terms, costs or charges established by Council; and,

AND WHEREAS the Safety Codes Act, RSA 2000, c S-1, as amended from time to time, authorizes an accredited municipality to make bylaws respecting fees for services provided pursuant to the Safety Codes Act; and,

AND WHEREAS the Access to Information Act, SA 2024, c A-1.4 (ATIA) and Access to Information Act Regulation, Alta Reg 133/2025, as amended from time to time, authorizes a local public body to by bylaw set any fees the local public body requires to be paid under the ATIA, which must not exceed the fees provided for in the regulations;

NOW THEREFORE, be it resolved that the Council of the Town of Vegreville in the province of Alberta, duly assembled enacts as follows:

1. SHORT TITLE

- 1.1 This Bylaw may be cited as the **2026 Fees and Charges Bylaw**.

2. DEFINITIONS

- 2.1 In this Bylaw:

- (a) **Act** means the *Municipal Government Act*, R.S.A. 2000, Chapter M-26, as amended
- (b) **Bylaw** means this Fees and Charges Bylaw established by the municipality
- (c) **Council** means the duly elected Council of the Town of Vegreville
- (d) **Town** is the municipal corporation of the Town of Vegreville.

3. PROVISIONS

- 3.1 The fees and charges contained in the attached Schedules 'A' to 'W' inclusive are hereby established and are subject to the applicable taxes where appropriate.
- 3.2 Where this Bylaw establishes a fee that also exists in another bylaw or policy that predates the effective date of this bylaw, the fee in this Bylaw shall be the applicable fee and other bylaw or policy is hereby effectively amended.

[Special events are billed on an hourly rate of \$100.00 per hour per discipline plus GST. The approximate amount of time for all inspectors to conduct the inspections and provide inspection reports are eight (8) hours. Depending on the severity of deficiencies, additional inspection trips may be required. It is highly recommended that you contact The Inspections Groups Inc. to obtain preliminary consultation on code requirements for your special event.

Should any work or construction start prior to obtaining the required Permit(s), the Town shall charge double the Permit Fees, to a maximum of \$500.00.
